Such a crime is punishable by both civil and clerical authorities, and, while Cecilia is banished to spend twenty years as a nun, Arn is sentenced to serve the same period as a Knight Templar in the Holy Land. As an occupation officer in Palestine, he discovers that the infidel Saracens don't appear to be brutish and uncivilised as they are portrayed in Christian propaganda. On the contrary, in love and war he learns from the example of his noble adversary Saladin that there's another side to the teachings of the Cistercians;
